

WEBSITE and PC OVERVIEW

You may find it helpful to read the following which will give you some information about our Parish Council and what we get involved with plus provide details about this website

1) Goldsborough & Flaxby Grouped Parish Council

Our Parish Council comprises a maximum of 7 Councillors and a Parish Clerk. There are also volunteers who generously give their time to cut grass, empty the litter bin and do checks at the Goldsborough Play Area. The Clerk is an employee of the Parish Council and is currently paid an annual salary based on 25 hours per month. The Councillors are not paid and generously give all their time free.

Every councillor provides a different skill set which we believe helps us to give a good varied view on any issues to be considered. There is a section on this website that gives their names and their Registered Interests.

In addition to attending Bi-Monthly Meetings (our meetings are in January, March, May, July, September and November) the Councillors get involved on very much an ad-hoc basis on a wide variety of issues that may arise relating to or affecting the two Parishes of Flaxby and Goldsborough. Those will include:

- Planning Applications
- Speeding
- Road signage
- Dog fouling
- Local crime
- Grass verge cutting
- Goldsborough Play Area
- Goldsborough Allotments
- Public benches
- Defibrillator (within the old Goldsborough Telephone Box)
- Footpaths and rights of way
- A Welcome Pack for newcomers to the villages
- A Newsletter (delivered three times a year)
- Circulation via email of information received that is relevant to residents within our two Parishes.
- This website

The Clerk deals with any administration such as issuing agendas and meeting minutes and, in addition is also the Responsible Financial Officer and prepares regular financial reports, pays bills, receives payments and provides appropriate accounts for the Internal and External Auditors.

Most of the income for our Parish Council comes via the Precept. For the current year ending on 31st March 2024 it is £7,350.00. This is paid by North Yorkshire Council (NYC) and comes out of the overall Council Tax payment it requires for each property. As there are approximately 280 properties in our two villages our Precept averages out at approximately £26.25 per property per annum. However, the actual charge within the Council Tax requested by NYC depends on the type of property and personal circumstances and therefore could be more or less than this.

In the last 10 years, our Parish Council has been required to get involved with more and more issues such as:

- i) In 2013 we took over the control and management of the Goldsborough Play Area as the original funds to maintain it following its installation in 2001 had run out.

- ii) In 2015 North Yorkshire County Council (as it was then before becoming a unitary authority in April 2023) 'cut back' on its grass verge cutting and the Parish Council took over this responsibility rather than see those local grass verges get badly overgrown.
- iii) To comply with the Transparency Code for Smaller Authorities, also in 2015, we had to set up and then provide an ongoing appropriate website.

These have all increased the expenditure levels and therefore the Precept of the Parish Council, not just from the cost of the companies doing the grass cutting, hosting our website or for work carried out at the Play Area, but also the cost of the additional time spent by our Parish Clerk administering them.

NYC has recently stated that Parish Councils in North Yorkshire such as ours will be allowed to get more and more involved with local issues that they currently deal with.

2) **This website**

This website is basically divided into:

- a) **Parish Council.** Showing our Agendas, Meeting Minutes, most recent Accounts, Audit documents, details about our Allotments, latest Play Area H&S Report, Planning Applications as well as Maps showing the extent of our two Parishes.
- b) **General Information.** Giving details of non-mandatory activities that our Parish Council is also involved with (such as a Villages Welcome Pack, Village Newsletters). In addition, this tab provides information considered of interest or use to residents of our two villages or for those visiting this website (for example The Knaresborough Round, Goldsborough Station and our villages during WW1 and WW2).

This information is updated when required so as to keep readers well informed of what is going on including being kept aware of all our income and expenditure.

This website is required to comply with GDPR (General Data Protection Regulations) and accordingly you will see our Privacy Notice on this website within General Information. In addition, more recent legislation has meant that this website is to comply with the Accessibility Regulations 2018. See below for more detail on this.
